Trees and landscaping

Estate maintenance

The Committee has been pursuing Land & Environmental Services depart at Glasgow City Council over the last two years, regarding the condition of paths and stairs in the estate. This has eventually had some success with work being done on the path and stairs connecting Burntbroom Gardens and Greentree Drive. We will continue to push them to complete this work and to address other areas including the path and stairs between Greentree Drive and Oakhill Avenue. The Council have also confirmed that they intend to spray all the pavements within the estate over the next couple of months so watch this space.



Watch your speed!

The committee has yet again received complaints from residents in all areas of the estate of speeding vehicles. The speed limit in the estate is 20pmh.

Please slow down. We have many children living in our estate who play in the streets and especially in the cul-desacs. The Committee has previously approached Glasgow City Council with a request for speed humps to be placed throughout the estate. Unfortunately they will only action this request once there has been an accident. In our opinion this would be too late. PLEASE WATCH YOUR SPEED!
